#### **AGILITY ASSOCIATION OF CANADA GENERAL AGREEMENT**

I/We, the undersigned, agree that the club holding this event has the right to refuse this entry for any reasons which the organizing committee deems sufficient. In consideration of the acceptance of this entry, the holding of the even and/or the opportunity to have this dog participate or be judged, I/We agree as follows: (I) while at or in proximity to this event, to freely assume all risk of loss (including death) or damage or injury, collectively called "Loss", to myself, this dog or any dog under my control, and to members of my family and my guests, and to our property; (II) to release and discharge and to hold harmless and indemnify the organizing committee, the club and its directors, officers and members, the sanctioning body for the event (if any), sponsors of the event (if any), and the owners of the premises grounds upon which the event is held and their respective employees and agents, collectively called the "Releasees", of and from any and all claims, and from all liability of any nature, for all Loss which I or this dog or any dog under my control or members of my family or my guests or our property may suffer for any reason or cause whatsoever, including specifically, but without limitation, all Loss resulting from the action or inaction of any dog, including this dog, or its owner or handler, or by the Releasees, or any of them whether through negligence or otherwise. - Contacting competitors by email or mail for future agility events, such as trials and seminars.

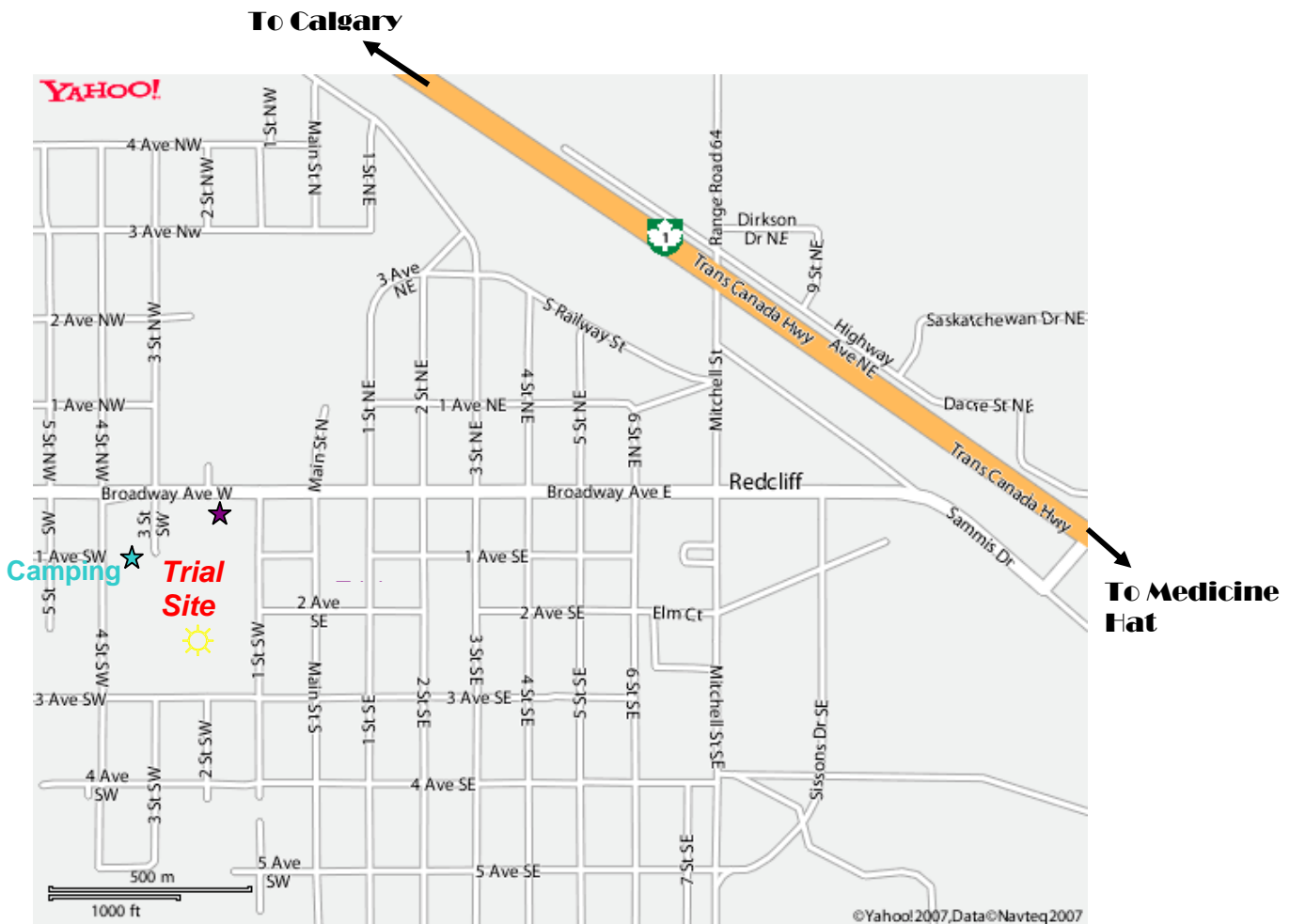
All information collected from or pertaining to all competitors will be kept private and confidential unless authorized in writing by the competitor. All paper copies of entries containing personal information will be destroyed after a period of six months.

Your entry into this agility trial will be added to a list of exhibitors available to all attendees unless you have indicated otherwise on your entry form.

### **Notice to Exhibitors**

- Exhibitors, through submission of entry, acknowledge they are knowledgeable of the rules and regulations of the AAC, including but not limited to the following:
- This event is held under AAC Rules and Regulations and is open to all dogs being at least 18 months of age, pure bred or mixed breed, except bitches in season, aggressive dogs, or dogs suffering from any deformity or illness which may affect the dog's physical or mental performance (Judges discretion).
- **\*\* As of January 1, 2001, all dogs must have an AAC number before their entries will be accepted in an AAC sanctioned trial. Dogs with numbers pending will not be eligible to compete.**
- Obstacles shall be chosen from those described in the current edition of the rules and regulations of the AAC and shall conform to AAC specifications.
- No leads, collars, food, toys or any other aids or devices shall be permitted on the course at any time. Toys and food shall not be permitted within 10 feet of the ring entrance.
- All dogs must be penned, crated or leashed when not in the ring. Please take responsibility for your dogs and children. Any exhibitor whose dogs and children create unnecessary disturbances or engage in unsafe or disruptive behaviour may be asked to leave the trial site. There will be no refunds for entries if an exhibitor is dismissed from competition for any reason.
- Refunds will not be given for cancellations after the closing date except for bitches in season or injury to a dog or handler that physically prevents them from competing. **Refunds requested for any other reason will be handled on a case-by-case basis and will be at the discretion of the Flashing Canines.**

## DRIVING DIRECTIONS

**From Calgary** (approximately 3 hours):

1. Go East on Highway 1.
2. Upon nearing Redcliff, turn right to go onto 8<sup>th</sup> St. NW.
3. Turn left onto Broadway Avenue.
4. Turn right on 3<sup>rd</sup> St. SW to enter trial site parking area.

**From Medicine Hat** (approximately 15 minutes):

1. Go West on Highway 1.
2. Turn left at second major intersection to go onto Sammis Drive.
3. Turn right onto Broadway Avenue.
4. Continue into Redcliff, go approx. 1.66km on Broadway Avenue (you will pass Flashing Canines Agility Club on the left) to 3<sup>rd</sup> St SW to enter trial site parking area.
